

It is understood that IEEE MetroAutomotive 2021 reserves the right, at its option, to reassign a canceled booth regardless of the cancellation rate assessed. In the event that the premises in which the IEEE MetroAutomotive 2021 show is conducted shall become, in the sole discretion of IEEE MetroAutomotive 2021, unfit for occupancy, or substantially interfered with by reason of any cause or causes not reasonably within the control of IEEE MetroAutomotive 2021, this agreement may be terminated by IEEE MetroAutomotive 2021.
